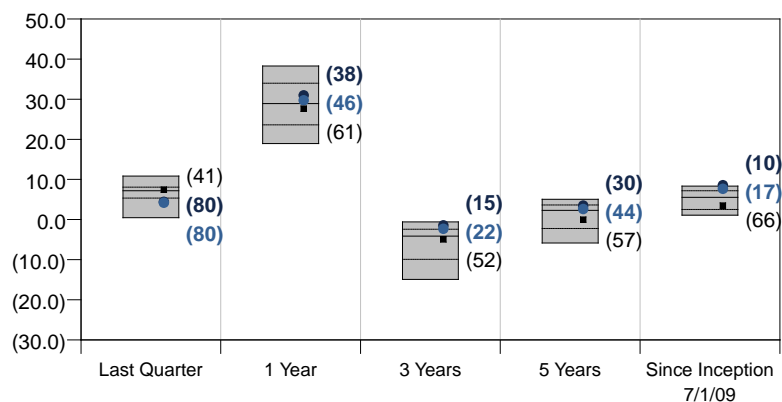
Investment Philosophy

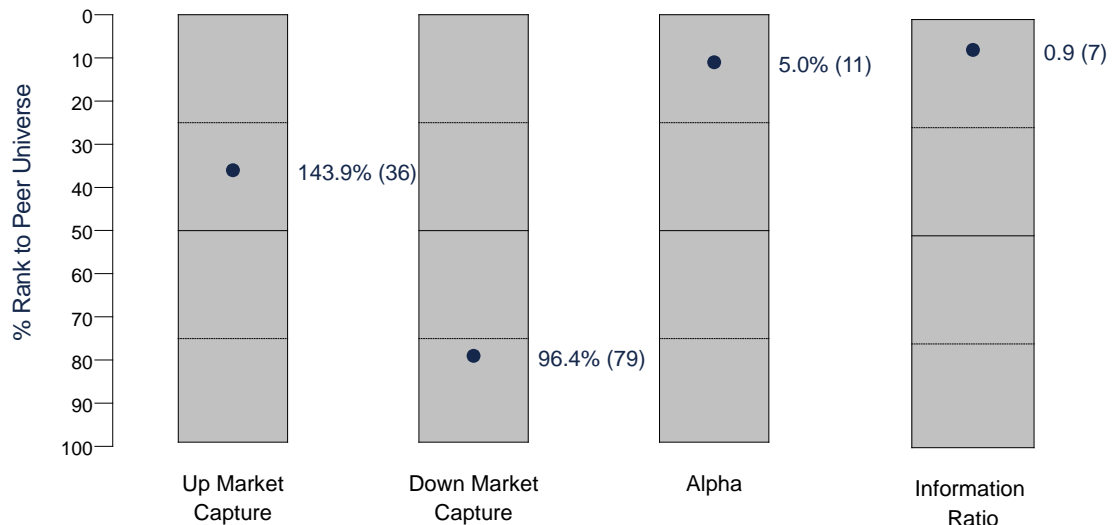

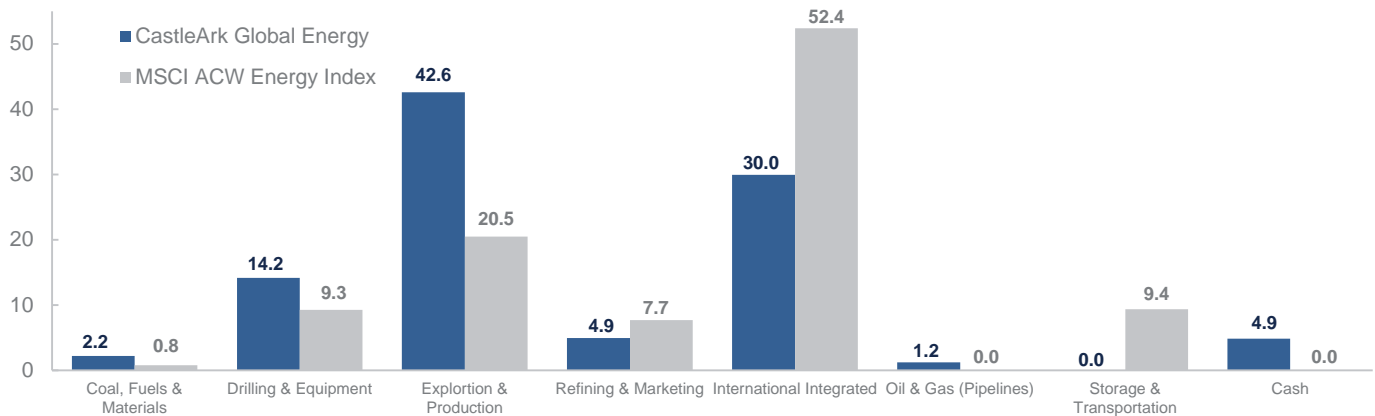


Risk-Adjusted Return Statistics vs. Lipper Natural Resources Universe: Since Inception
